

## Covid-19 Asia and the Pacific Travel and Containment Information Sheet

04.08.2020

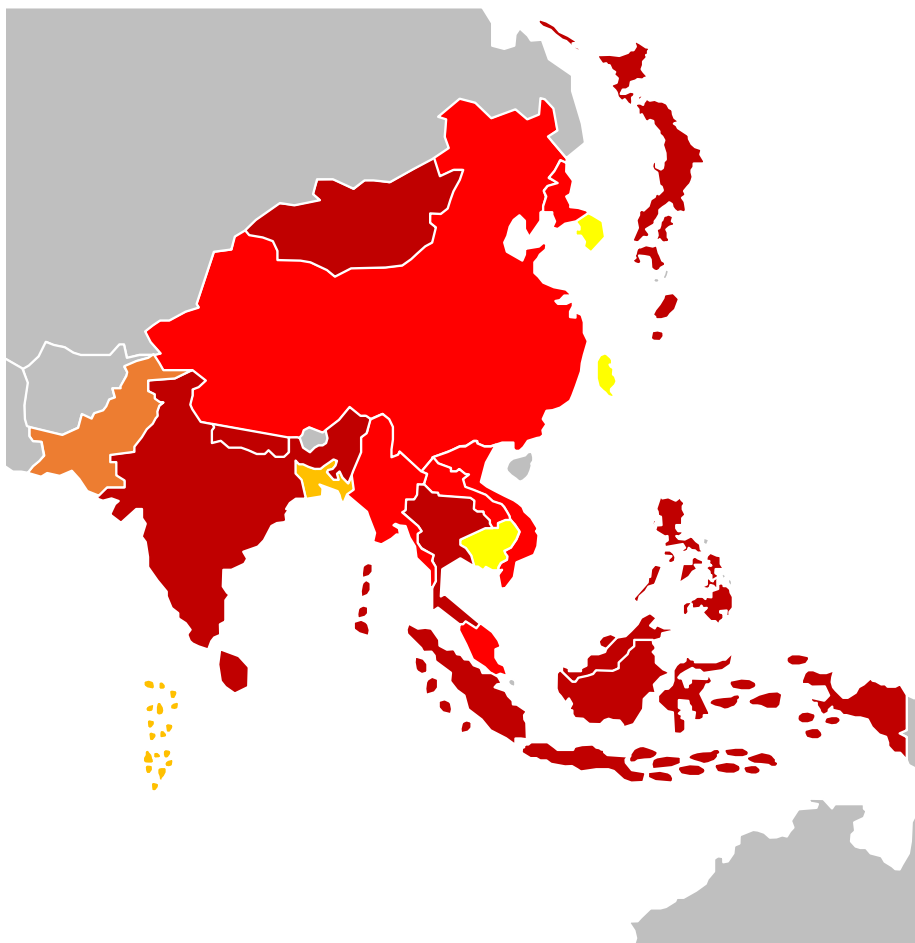
**Overall take:** Restrictions is currently standing still. Most countries have relaxed travel and social restrictions. Domestic travel possible in most APAC countries, but are likely to be restricted. Intentional travel is mostly banned. In response to a resurgence of Covid-19 some restrictions are re-imposed.

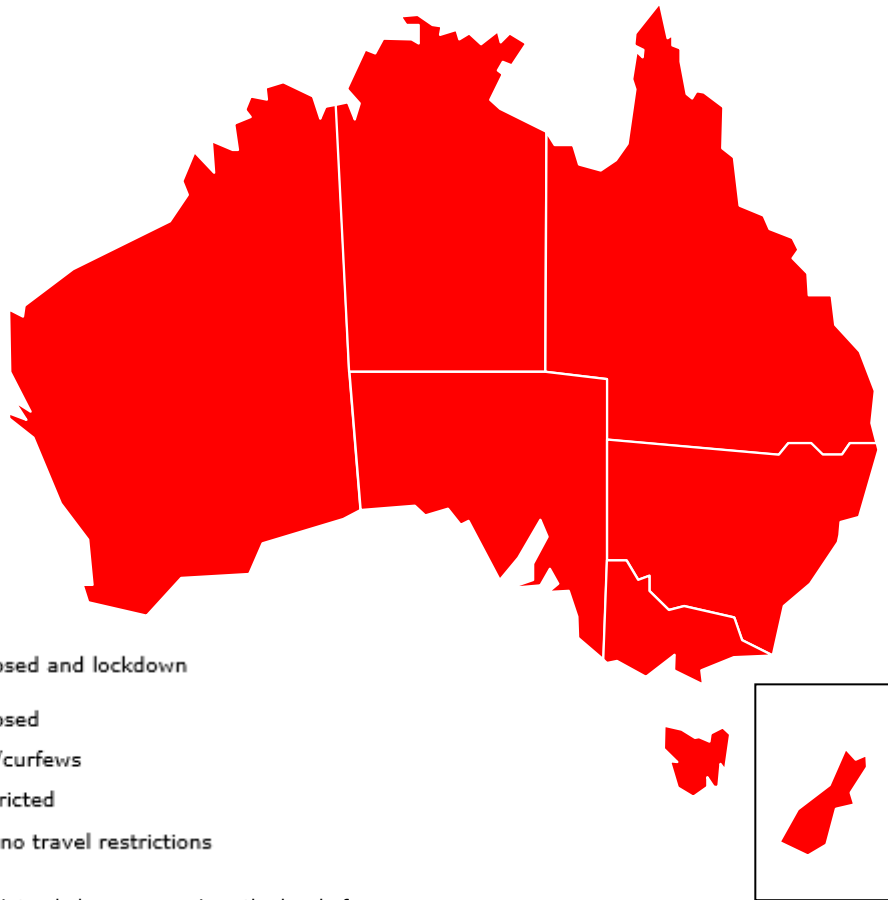

**About:** The following is a brief overview of travel restrictions and containment measures for countries in Asia and the Pacific. This is a work in progress and efforts are being made to improve the collection and centralization of relevant inputs. Data collection was performed manually, and sources include national foreign ministries, embassies and consular missions abroad, and select newspapers of record.

**Note:** Keep in mind, information on this sheet it subject to rapid change. *This should be referenced as a starting point only.* **Travelers and their stakeholders are strongly encouraged to perform regular due diligence on travel destinations and transit routes before embarking on international travel as containment measures and travel restrictions change by the hour.**

### Regional Overview





Note: This map is intended as an overview, the level of lockdowns and travel restrictions may vary. Countries may have different restrictions depending on the state.

Bangladesh	<ul style="list-style-type: none"> <li>• <b>Social restrictions relaxed. People can attend prayers and business centres, malls etc. are allowed to open between 10:00 and 19:00.</b></li> <li>• In other areas are lockdown eased, though curfew is still present between 22:00 – 06:00 <b>until 31<sup>st</sup> of august.</b></li> <li>• Some flights resumed these include; UK, Malaysia, Turkey, the UAE, Qatar, Sri Lanka, China and the Maldives. Flights from following countries are still suspended: Bahrain, Bhutan, Hong Kong, India, Kuwait, Nepal, Oman, Saudi Arabia, Singapore, and Thailand.</li> <li>• Train services to and from India suspended.</li> <li>• Limited public transport available.</li> <li>• Foreign nationals with valid visas will be required to produce a medical certificate (with English translation) to be obtained within 72 hours of travel, indicating that they do not have any symptoms of Covid-19. Cambodia	<ul style="list-style-type: none"> <li>• <b>Cambodia lift entry ban on travellers from USA, Germany, Italy, Spain, France and Iran.</b></li> <li>• Incoming travellers must pay a deposit of 3000 USD for Covid-19 testing and potential quarantine.</li> <li>• The Thailand, Laos and Vietnam border are closed.</li> <li>• Temperature screenings are conducted at international airports. If the traveller has any symptoms connectable to Covid-19 e.g. cough, the traveller will be quarantined.</li> <li>• State of emergency expanded until further notice.</li> <li>• All travellers entering Cambodia will have to go into quarantine for 14 days in designated facilities.</li> <li>• VISA extensions will be denied for foreigners that are not registered on the Foreigners</li> </ul>	



	<p>Present in Cambodia System by 1<sup>st</sup> of July 2020 (this is the landlords/hoteliers responsibility).</p> <ul style="list-style-type: none"><li>• Travellers to Cambodia (also Cambodian nationals) must have:<ol style="list-style-type: none"><li>1. a health certificate that is no longer than 72 hours old, and that state that the traveller does not have Covid-19.</li><li>2. A financial statement saying that you have at least 50.000\$ for medical coverage.</li></ol></li><li>• All visa free entry and the issuance of all e-visas and visas-on-arrival for all foreigners will be suspended for a period of one-month, effective as of 31<sup>st</sup> of March.</li><li>• At arrival all travellers must undergo a medical test upon arrival. Foreigners must pay themselves for the test.</li><li>• Ban on travel between provinces has been lifted.</li></ul>	
China	<ul style="list-style-type: none"><li>• <b>Restaurants, café's and bars are open</b></li><li>• International flights banned until 30<sup>th</sup> of June. Ban lifted on US and 95 other airlines.</li><li>• All arriving passengers must possess a negative nucleic acid test certificate for Covid-19 issued by a facility recognized by the Chinese Embassy within five days prior to boarding the flight.</li><li>• Entry of foreign nationals suspended. The only exemptions will be diplomatic, service, courtesy or C visas. Only those with a visa issued on or after 27 March will be allowed to enter China. This also counts for transit passengers. If the traveller does enter China, they must admit to a 14-day quarantine at own expense.</li><li>• If the travel is related to necessary economic, trade, scientific or technical activities, emergency humanitarian needs may apply for a new visa.</li><li>• Travellers that do arrive in China from overseas will be subject to health checks followed by centralised quarantine. Families might be split when being put into quarantine.</li><li>• All international flights to Beijing are diverted to 12 designated airports. Passengers that are cleared in a Covid-19 screening can then board a plane to Beijing.</li><li>• Healthy residents of the Hubei province can leave the province. Anyone who has a green code can leave the area.</li><li>• Lockdown imposed in Suifenhe, Heilongjiang province. Only one family member is</li></ul>	



	<p>allowed to leave the house to go and buy essentials and they must return on the same day.</p> <ul style="list-style-type: none"><li>• Quarantine, also at government designated facilities, must be paid by the traveller self.</li><li>• Chinese nationals are not allowed to cross the border to Vietnam.</li><li>• Face masks must be used in public transport, at hospitals, schools or nursery homes.</li><li>• Temperature is likely to be measured when entering grocery stores.</li><li>• Restrictions might differ depending on region.</li><li>• Hong Kong people that cross the Guangdong border must show a health certificate no more than 72 hours old and must quarantine at a government approved facility.</li></ul>	
Hong Kong	<ul style="list-style-type: none"><li>• <b>From 1<sup>st</sup> of June transit passengers will be allowed in Hong Kong Airport.</b> All passengers must wear face masks and undergo temperature screenings.</li><li>• <b>Transit possible from 15<sup>th</sup> of June</b>, though transiting to and from mainland China not possible. Face masks are mandatory in the airport.</li><li>• Ban on non-resident foreigners until 18<sup>th</sup> of September (unless they have spend 14 days in either China, Macau or Taiwan before arrival).</li><li>• <b>Education institutions are allowed to open from end May.</b></li><li>• <b>Travel ban on travellers from Macau and mainland china will be lifted. It will still be in effect for all other travellers.</b></li><li>• Compulsory quarantine for anyone, regardless of nationality, arriving in Hong Kong who has travelled to any overseas countries/territories within a 14-day period. The quarantine is either home quarantine, if the traveller has an address, or in a government quarantine facility. Individuals are not allowed to leave their designated quarantine location for 14 days, which means they will also be unable to leave Hong Kong for the duration of the quarantine. Your position must be shared with the Hong Kong government.</li><li>• All travellers will be tested for Covid-19 upon arrival. Travellers must wait for test results before being transported to quarantine location.</li></ul>	<ul style="list-style-type: none"><li>• LegCo Elections postponed until 2021</li></ul>



	<p>Travellers are required to quarantine for 14 days.</p> <ul style="list-style-type: none"><li>• Social distancing measures increased groups of more than four banned.</li><li>• Face masks mandatory in public transport. India	<ul style="list-style-type: none"><li>• International flights are not permitted to land in India <b>until 31<sup>st</sup> of August.</b></li><li>• <b>Domestic flight to resume from 25<sup>th</sup> of May.</b></li><li>• Travellers need a visa to enter India. This can be applied for before departure. It must be valid for purpose and duration of the stay.</li><li>• Foreigners are banned with a few exceptions, e.g. health specialists, engineers and health professions.</li><li>• Travellers that arrive in India must undergo 14 days quarantine (7 days at a state facility and 7 days at home)</li><li>• Religious establishments are allowed to open outside of the red containment zones</li><li>• Uptick in Covid-19 cases cause some cities to reimpose lockdown e.g. Chennai, Tiruvallur and Ponneri - <b>no common end date</b></li><li>• India has been divided into “green”, “amber”, and “red” zones based on the level of infection. Level of restrictions vary between these zones. Be aware that individual states and zones might differ in restrictions.</li><li>• Lockdown eased outside containment zones. This means that shops (except medicine and grocery), commercial establishments, shopping malls, educational institutes, government and private offices, local transport including public transport, incl. bus, rail and metro, and taxi, domestic and international flights have been reopened.</li><li>• Nationwide a nightly curfew is imposed between 22:00 – 05.00.</li><li>• Face masks are mandatory when in the public.</li><li>• Public gatherings in bigger groups banned.</li><li>• Self-employed people e.g. plumbers and cleaners are allowed to resume their work.</li><li>• Railway Board announce that all most all services are suspended until the 12<sup>th</sup> of August.</li><li>• Lockdown in containment zones remains <b>until August 31<sup>st</sup>.</b></li><li>• International Flight restrictions extended until</li></ul>	<ul style="list-style-type: none"><li>• Covid-19 restrictions are generally extended to <b>August 31<sup>st</sup></b> in Nagaland state and to <b>August 6<sup>th</sup></b> in Manipur state.</li><li>• All visitors to Jammu and Kashmir required to self-quarantine or test negative.</li></ul>

Indonesia	<ul style="list-style-type: none"><li>• <b>Domestic air and sea travel resume to about 70%.</b></li><li>• <b>Social distancing measures gradually relaxed</b></li><li>• <b>Bali to reopen tourist facilities for locals from the 9<sup>th</sup> of July</b></li><li>• <b>Bali to reopen borders to all domestic travellers from 31<sup>st</sup> of July</b></li><li>• <b>Bali to reopen to international travel from 11<sup>th</sup> of September</b></li><li>• Foreigners banned for entering and transiting the country.</li><li>• Government officials announce that all foreign travellers except diplomats or those with work permit, will be barred from entry and transit through Indonesia until further notice.</li><li>• All visitors must present a health certificate before departure to Indonesia.</li><li>• Airports test arriving passengers for Covid-19.</li><li>• Closing of schools, universities, and cultural institutions.</li><li>• Face masks mandatory, also for motorists.</li><li>• Be aware that restrictions might differ between provinces and islands.</li></ul>	
Japan	<ul style="list-style-type: none"><li>• <b>State of emergency lifted in Tokyo, Kanagawa, Chiba, Saitama, Hokkaido, Osaka, Kyoto and hyogo.</b></li><li>• Inter – prefectural travel restrictions lifted.</li><li>• Entry ban on all non-Japanese citizens. Travellers from 129 countries are banned from entry:</li><li>• Demands transit visa it is not possible to do a transit from a country that is banned from entry.</li><li>• Due to a spike in Covid-19 cases are residents in Tokyo are asked to stay home unless it is strictly necessary to go out.</li><li>• Single and multiple entry visas are suspended.</li><li>• There are enhanced quarantine procedures at entry points to Japan such as airports and ports. The authorities may carry out extended health checks on arrival including compulsory hospitalisation. You should comply with any additional screening measures by the authorities if asked to go through extra checks.</li><li>• High speed train (shinkansen) will be reduced by 40 percent beginning from the 28<sup>th</sup> of May.</li></ul>	



Laos	<ul style="list-style-type: none"><li>• <b>Some domestic flights resumed</b></li><li>• <b>Movement restrictions eased. Inter-regional possible. Social gatherings of more than 50 people banned. Restaurants and shops can reopen.</b></li><li>• All international borders closed <b>until further notice.</b></li><li>• International flights banned until further notice.</li><li>• Incoming travellers will be subject to health tests and a 14 – day quarantine at own expense.</li><li>• Visa only possible for business travellers, applicants must also submit a health certificate. No visas are issued to people travelling from a country with Covid-19.</li><li>• Returning students, Lao citizens, skilled workers and diplomats will be able to enter and exit the country.</li></ul>	
Macau	<ul style="list-style-type: none"><li>• All transit services have been suspended at Macau International Airport.</li><li>• If a traveller shows signs of Covid-19 they may be subject to compulsory quarantine if the traveller does not follow this, they might face criminal prosecution.</li><li>• Transit services will be suspended.</li><li>• Entry of non-residents from all overseas countries/territories, except those from Hong Kong, Taiwan, or mainland China prohibited.</li><li>• Non-Macau residents complete the quarantine period at a designated hotel at their own expense.</li><li>• All ferry crossings between Hong Kong and Macau has ceased until further notice. The bridge between Hong Kong and Macao will remain open. Bus services between Hong Kong and Macau suspended.</li><li>• All arriving passengers, also Macau citizens, must have a certificate confirming that they are tested negative for Covid-19 within the last 7 days, before they can board a flight to Macau. Anyone with a fever will be refused boarding.</li></ul>	
Malaysia	<ul style="list-style-type: none"><li>• <b>The movement control order will be gradually lifted from 10<sup>th</sup> of June until 31 of August.</b></li><li>• Movement restrictions and lockdown measures are in place though the degree varies from state to state.</li><li>• Foreign nationals banned from entering the</li></ul>	





	<p>country. Exceptions for diplomats, people with permanent residence or expatriates that work in an essential business.</p> <ul style="list-style-type: none"><li>• Travellers returning from overseas will be quarantined at a government facility for 14 days at own expense.</li><li>• It is now mandatory to wear face masks in public spaces, failure to do so will result in a fine.</li><li>• All travellers that arrive in Kuala Lumpur airport will be Covid-19 tested. If they are negative, they will be quarantined for 14 days. If it is positive, they will be transported to a designated hospital.</li><li>• The border between Thailand and Malaysia has been closed until further notice.</li><li>• All foreigners are encouraged to go home. Travellers with a temperature above 38 are not permitted to leave</li><li>• Foreign nationals may transit through Malaysian ports of entry if they are not required to pass through immigration within Malaysia while in transit.</li><li>• Shops (except for grocery shops), Schools, universities are closed</li><li>• Passport must be carried at all times.</li><li>• Cinemas, theatres, meetings, conferences, public swimming pools, and live events are allowed to resume, if they keep the social distancing with a capacity of 250 from 1<sup>st</sup> of July.</li><li>• In Kuala Lumpur airport it is not possible to shift between KLIA and KLIA2. Maldives	<ul style="list-style-type: none"><li>• <b>Lockdown orders in Kulhudhuffushi lifted.</b></li><li>• <b>Commercial International flights resumed</b></li><li>• <b>Borders will reopen to tourists on the 15<sup>th</sup> of July. Hotels, resorts and cruise ships, docking at uninhabited harbours can house tourists. In habited islands will open from 1<sup>st</sup> of august.</b></li><li>• Entry ban on travellers <b>lifted</b> (also regarding transit) from or who the latest 14 days has been to Korea, Iran, China, Bangladesh, Germany, Spain, France, Malaysia, USA, and Italy.</li><li>• Health emergency extended <b>until the 7<sup>th</sup> of August.</b> Curfew in greater Male area between 23.00 and 05.00.</li></ul>

Mongolia	<ul style="list-style-type: none"><li>• <b>All commercial flights are cancelled</b></li><li>• <b>All inbound and outbound vehicle traffic to and from Ulaanbaatar, Darkhan City, and Selenge District is allowed again from 25<sup>th</sup> of April.</b></li><li>• <b>From 1<sup>st</sup> of May gyms, swimming pools and leisure centres can open if they have correct sanitary measures.</b></li><li>• All inbound travel from foreign locations are suspended <b>until 31<sup>st</sup> of August</b>, this also include all auto and train travel. Prohibition of intercity travel.</li><li>• Prohibition of public gatherings until <b>31<sup>st</sup> of August.</b></li><li>• Closure of schools, universities, cinemas and entertainment centers until <b>1<sup>st</sup> of September.</b></li><li>• Visitors to public offices are subject to temperature screenings and required to wear a facemask.</li><li>• Border closed with China. Myanmar	<ul style="list-style-type: none"><li>• All land borders closed to foreigners.</li><li>• All arriving travellers must do 14 days quarantine on a public hospital or other facility.</li><li>• Commercial flights into the country are suspended at least <b>until 31<sup>th</sup> of August.</b></li><li>• Curfew in Yangon between 00.00 – 04.00-</li><li>• Face masks must be worn in public</li><li>• Social gatherings more than 5 prohibited</li></ul>	<ul style="list-style-type: none"><li>• All covid-19 restrictions extended <b>until 31<sup>st</sup> of August.</b></li></ul>



	<p>When travelling between parts of the country, the traveller might face a demand for 28-days quarantine.</p> <ul style="list-style-type: none"><li>• All incoming foreign nationals will have to present laboratory evidence that they do not have Covid-19 72 hrs before boarding.</li><li>• The traveller must present evidence of a medical insurance of at least 100000 USD.</li><li>• <b>Stay home order lifted in, Mingaladon, Hlaing, Tharayar, Shwe Pyi That and Botathtaung.</b></li><li>• <b>Quarantine lifted for incoming domestic travellers from Mandalay, Ayeyarwady, Tanintharyi, Kayah, Kayin, Mon and Shan</b></li><li>• Foreigners with a valid visa can travel out of Yangon, Mandalay and Naypyotaw airports.</li><li>• Visa free travel with China suspended.</li><li>• Temperature scans and travel history at all ports of entry.</li><li>• Immediate suspension of visas for foreign nationals. No further issuing to Foreign nationals.</li><li>• Travellers who have recently visited Europe, United States and the United Kingdom must present at health certificate and will be placed in government quarantine facilities for 14 days on arrival; and travellers who have visited China or the Republic of Korea will not be permitted entry. The health certificate must confirm the absence of infection within the last 72 hours.</li><li>• If you test positive for the virus, you are highly likely to be transferred to a government quarantine hospital until you are recovered. Patients will be obliged to use a government facility even if they have private insurance. Patients in government hospitals are expected to make their own arrangements for bringing in food and other essential supplies. Lone travellers will not be allowed out of isolation to purchase food or make phone calls.</li></ul>	
Nepal	<ul style="list-style-type: none"><li>• <b>Essential construction activities resumed</b></li><li>• <b>International flights to resume from 17<sup>th</sup> of August.</b></li><li>• <b>Domestic flights to resume from 5<sup>th</sup> of August.</b></li><li>• All land points of entry will be closed until further notice.</li></ul>	



	<ul style="list-style-type: none"><li>• Curfew imposed due to spike in covid-19 cases, between 22:00 – 05:00. Only essential workers will be exempt from this measure.</li><li>• International and domestic flights suspended until <b>the 1<sup>st</sup> of August</b>.</li><li>• All public and educational facilities have been <b>closed until further notice</b>. Gatherings of more than 25 people have been restricted.</li><li>• Domestic travel restrictions relaxed. Vehicles with odd numbered plates can drive on odd numbered days and vice versa. Travel between districts must be approved by the chief district officer.</li><li>• Shops are beginning to open but only serves people with face masks.</li><li>• Face mask has become mandatory to wear in public spaces.</li></ul>	
New Zealand	<ul style="list-style-type: none"><li>• <b>Domestic travel is now permitted.</b></li><li>• <b>Alert level further decreased to level 1 at the 9<sup>th</sup> of June.</b> Social distancing and limits to gatherings are no longer active.</li><li>• Entry ban for non-New Zealand citizens</li><li>• Travellers quarantines for 14 days when arriving to New Zealand in an approved facility.</li><li>• Biosecurity screening at all international airports.</li><li>• Transit possible though with restrictions. The transit must maximum last 8 hours. Transit travellers must be asymptomatic and have a valid ticket onwards as well as permit to enter destination country. Travellers cannot enter New Zealand.</li><li>• New Zealand officials hold off bookings of New Zealand nationals who want to be repatriated home to prevent facilities from getting overwhelmed.</li></ul>	
North Korea	<ul style="list-style-type: none"><li>• Borders closed with Russia and China.</li><li>• Entry ban on all foreign tourists and North Koreans in China.</li><li>• National emergency implemented and related quarantine measures in place <b>until the end of 2020</b></li></ul>	<ul style="list-style-type: none"><li>• Lockdown in Kaesong</li><li>• State of alarm upgraded to <i>maximum emergency</i>, non-essential movement and businesses operations banned.</li><li>• Face masks required in public.</li></ul>



Pakistan	<ul style="list-style-type: none"><li>• <b>Limited domestic flights are resumed from Islamabad, Lahore, Karachi, Quetta and Peshawar.</b></li><li>• <b>Small shops and markets are allowed to open from Monday to Friday.</b></li><li>• <b>Outbound international flights resumed.</b></li><li>• <b>Inbound international flights allowed on case to case basis.</b> Travellers must fill out a health declaration and take a covid-19 test.</li><li>• Authorities reimpose lockdown measures in areas with high rate of Covid-19 cases in parts of Islamabad, Lahore, Peshawar, Karachi, Quetta, Rawalpindi, Faisalabad, Multan, Gujranwala, Swat, Hyderabad, Sukkar, Sialkot, Gujarat, Ghotki, Larakana, Khairpur, DG Khan, Malakand and Mardan.</li><li>• <b>Lockdown lifted in G-6/1, G6/2 and G7/2 sub-sectors of Islamabad.</b></li><li>• Facemasks mandatory in public.</li><li>• Borders closed with Iran, China, India, and Afghanistan.</li><li>• Mandatory quarantines in place for high risk individuals.</li><li>• Closing of schools and cancellation of public, private and sport events. Public gatherings are banned. Rail operations across Pakistan suspended.</li><li>• All incoming travellers to Pakistan must submit a copy of a Covid-19 test before departure to Pakistan. The test must specify full name, passport number and original test must be shown upon arrival.</li><li>• Differences occur between provinces. Failure to follow containment measures can be punished with fines or jail.</li><li>• Passengers arriving in Pakistan are required to self-isolate for 14 days. The Pakistani Civil Aviation Authority will quarantine all passengers on arrival. Either in a government arranged facility or in a self-arranged. Airlines must record which facility passengers prefer.</li></ul>
